Fax a copy of the original deposit slip with bank stamp to Sierra A.S.A.P. that clearly shows that it was an electronic transfer, local bank check, or a cash transfer. You must transfer the exact amount owed to Sierra Auction

AUCTION TERMINOLOGY

The following is a list of words or terms that you should be familiar with when bidding. If you have questions about any of these terms or any others that the auctioneer may use, we encourage you to familiarize yourself with them prior to bidding.

Times the money: The expression "times the money" is used when two or more like items are being sold at one time; in this instance your bid is multiplied times the number of items being sold. Example: Lot number 142 is four identical Cell Phones and the auctioneer announces that the auction lot is being sold "times the money". The high bidder purchased lot 142 for \$100. In this example, the successful bidder bought each of the four Cell Phones for \$100.00 for a total of \$400.00 (4 x \$100= \$400).

Choice: On occasion, there will be multiple lots of identical or similar items sold consecutively in the auction. In some instances the auctioneer will sell those consecutive lots via "choice". When selling "choice", the auctioneer is offering more than one item up for auction at a time. The winning bidder then has the choice to take one item or multiple items. If the bidder wishes to take more than one item, the bid price will be multiplied by the amount of items the bidder chooses. **THE WINNING BIDDER MAY BUY ALL THE ITEMS!**

Choice in Order: When the auctioneer announces that the items are being sold "Choice in order", it means that the buyer may choose to take the first numerical lot of those announced as currently being sold, or as many, or all items, as they choose to take, but must take them in sequential number order, and will pay the bid price for each of the lots that the successful bidder wishes to purchase.

AS-IS: All items are sold without warranties as to the condition and/or the fitness of the property for a particular use. Buyers are solely responsible for examining and judging the property for their own protection; otherwise known as "As Is, Where Is" and "In its Present Condition."

Bidder Number: Individually numbered card with your unique bidder number. This will identify you to the auctioneer as the successful bidder.

Bidder Registration: The process of registering your identity and ability to pay for successful bids. This is essential before bidding.

ATTENTION: Per City Code 2-132, if you are a City of Phoenix employee, you are not permitted to bid on any City of Phoenix assets, either knowingly or unknowingly. By participating in our auction you are certifying that you are aware of this code and will abide by it.

Sierra reserves the right to change these terms and conditions at any time at its sole discretion and without notice. Recording of the auction is strictly prohibited; no still, video or audio recording can be made without the express written permission of Sierra. No firearms allowed pursuant to A. R. S. section 4-229.

Sierra Auction Management, Inc. ("Sierra") is acting as an auctioneer-agent for many cities, counties, the State of Arizona, many large and small companies and people just like yourself that are seeking to sell items they no longer need. Sierra may act as a Principal, Buyer or Seller in the sale of some items. Sierra is not responsible for the actions of its consignors and/or principals.

A Valid ID is required to register, pay, and pickup at all Sierra Auction locations.

REGISTRATION: All Buyers must register and be assigned a bidder number prior to bidding. Sierra reserves the right to deny access to its premises to any buyer, visitor, or guest at its sole discretion. Sierra may revoke any bidder's rights to bid at any Sierra auction, or all future Sierra auctions at its sole discretion. PROXBID \$100-\$500 REGISTRATION DEPOSIT/HOLD: If you, the buyer, registers for any of our auctions through Proxibid and DO NOT meet Proxibid's MarketGuard criteria for bidding, Proxibid will require either a \$100 deposit hold (firearms ONLY) or a \$500 deposit hold (vehicles & commercial equipment) in order to participate in our auctions. This deposit/hold CAN be applied to your final invoice total ONLY if used for the final payment balance of the item(s). Deposit/hold refunds can take up to 30 days depending on the time it takes YOUR bank to release. If you ARE the winning bidder of an item in auction and payment has not been made according to Sierra's terms and conditions, the \$100-\$500 registration deposit hold will be charged as a penalty for breaching the purchase contract.
